Application is hereby made for construction light permit with CAMARINES SUR II ELECTRIC COOPERATIVE, INC., in the above address, for which I bind myself to the following terms and conditions, to wit;

- That the Temporary electrical permit secured by the applicant from Building official, city/municipality for the purpose of construction lighting is only good for a period of _____ days after which if the construction is not yet finished, the applicant shall inform the cooperative in writing and pay an extension fee for the construction light, to be determined by the cooperative; Provided, however, that after the expiration of the _____ day period or its extension, the applicant should apply for a PERMANENT SERVICE CONNECTION: Provided, further that for the failure of the applicant to do so, CASURECO II may disconnect the temporary service connection/construction light without the need of disconnection notice;
- To comply with the article of incorporation, by-laws and rules and regulations now existing and others that may from time to time be adopted by the cooperative;
- To allow during reasonable time of the day or night the representatives/employees of the cooperative and upon their latter's demand upon me or to any of my construction workers, foremen, and/or engineer/ supervisor or any person working/living therein of sufficient age and discretion, to enter my premises for the purpose of collection, disconnection, installation, wiring connection/ outlet inspection, load inspection/ computation, meter reading and for any such other purposes related to the cooperative's function. I further agree that refusal on my part or by any of my men, workers or relations to effect the herein mentioned purposes shall be ground for the cooperative to immediately discontinue electrical service and/or refusal for further reconnection of electric services.
- To pay the repair on damage cooperative property or loss of same through negligence or misuse on my part, my employee or household members,
- To be held responsible/liable for tampering kilowatthour meter, breaking of seal and other electrical equipments installed by the cooperative in my premises as provided for R.A. 7832.
- To grant the cooperative the right to determine the location of the kilowatthour meter and/or its relocation if necessary, for safety measures and for such other purposes as may be determined by the cooperative; and to discontinue service for non-payment of electric bills and/or other obligations due to the cooperative.
- To exempt the cooperative from any liability in case of power interruption arising from force majeure and such other fortuitous events and to further grant the cooperative the power to suspend service at such manner may in its judgement, be required for the purpose of making necessary repairs on its distribution lines and other parts of the system;
- This contract shall take effect when the connection is made and effected by the cooperative.
